ONCE DETERMINED, THE CHAIR INFORMS THE CFO IN WRITING ABOUT THE BOARD DECISION, INCLUDING A DESCRIPTION OF WHAT THE COMPENSATION WILL INCLUDE. 2018 WAS THE MOST RECENT YEAR IN WHICH THE PROCESS INCLUDED REVIEW AND APPROVAL BY INDEPENDENT PERSONS, COMPARABILITY DATA, AND CONTEMPORANEOUS SUBSTANTIATION OF THE DELIBERATION AND DECISION.
